Safe work procedure to prevent worker exposure to avian influenza virus

DO NOT perform this procedure until you have been properly trained and authorized to do so by your supervisor

REQUIRED TRAINING

- Consider getting current season flu vaccine.
- Tool box training on this safe work procedure.
- Avian influenza response plan on the farm as per CFIA / Health Canada recommendations.
- Respirator fit testing and training.

POTENTIAL HAZARDS

- Avian influenza virus.
- Vapours and splashes from chosen disinfectant.
- Tasks which involve the handling of live or dead birds, their faeces, feathers or bedding, or the cleaning and disinfection of contaminated surfaces or equipment could potentially expose the worker to avian influenza virus.

SAFE WORK PROCEDURE

Before you start:

- 1. Inspect required personal protective equipment (PPE) and replace if required.
- 2. Put on all required personal protective equipment.
- 3. Check for any signage or barriers advising against worker entry to barn.
- 4. Examine flock for any signs of avian influenza know the signs such as sudden death, lack of coordination, lack of energy and appetite, soft-shelled or misshapen shells, decreased egg production, purple discolouration of the wattles combs and legs. Swelling of the head, eyelids, combs, nasal and hocks, diarrhoea, nasal discharge, coughing and sneezing.



AVIAN INFLUENZA EXPOSURE PREVENTION

While You're Working:

- 1. Ensure your PPE is fitted and maintained in a sealed fashion.
- 2. Avoid eating drinking and smoking or removing PPE.
- 3. Continue to practice good hand and exposed skin washing technique between glove changes, washroom breaks etc.
- 4. Avoid touching exposed skin, face, eyes, nose and mouth whilst wearing PPE.

After You Finish:

- 1. With your respirator, goggles and gloves on, remove all personal protective clothing.
 - a. Place disposable clothing in an approved secure container for disposal
 - b. Place reusable clothing in approved, secured containers for cleaning and disinfection on site
- 2. Remove gloves and discard them in an approved, secure container for bio-hazardous waste.
 - a. Thoroughly wash hands and fingers with soap and water
 - b. If no hand washing facilities are available, use waterless soaps or alcohol-based sanitizers provided by your employer

If an emergency situation occurs while conducting this task, or there is an equipment malfunction, shut the equipment off immediately and follow the lock out procedure.

Report any hazardous situation to your supervisor/manager or employer immediately
